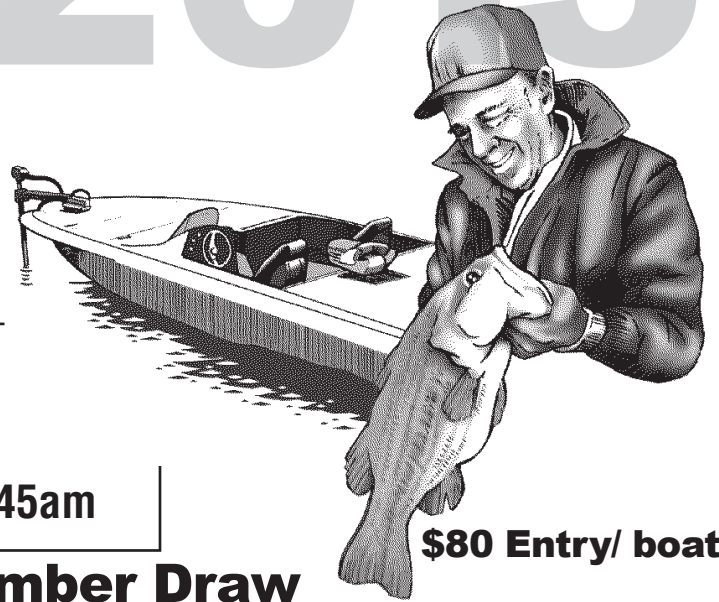

Bernie Behnke Scholarship Tournament Rules

1. **Participation** - Tournaments are open to all persons 18 years and over. If under 18 you must be accompanied by parent or guardian.
2. **Entry Fee** - Entry fee for all tournaments will be \$80.00 per team.
3. **Payback** - Payback will be based on one spot for every 5 entries.
4. **Limit** - This is an five (5)-fish-limit tournament. Anyone bringing in more than five fish will have their sack culled to the five-fish limit starting with big fish first. If you are fishing alone you will be disqualified. State law prevails.
5. **No Live Bait** - Artificial lures only. Pork trailers accepted.
6. **No Trolling or Drift Fishing** - This will not be tolerated. Anyone found to be doing this will be disqualified for that tournament and put on probation for the remaining tournaments. Any other infraction of any rules/regulations, you will be disqualified for the year end classic.
7. **Protest** - All protest must be submitted in writing to tournament director no later than 15 minutes after close of weight-in. Verbal protests will not be accepted.
8. **Penalties** - All fish brought to weight-in must measure 14 inches in length. Any short fish will be culled along with big fish in sack. Courtesy bump will be given by weighmaster. A courtesy board will be available.
9. **Dead Fish** - There will be a deduction of four ounces (.25 lbs.) for each dead fish.
10. **Late** - Penalty per minute is 1 lb. for 1 minute. Total of 5 minutes late is an automatic disqualification.
11. **Tournament Hours** - All tournaments will start at 7:00am and end at 3:00pm
12. **Registration** - There will be registration at tournament site starting at 5:30am.
13. **Take-Off** - First 40 boats entered for Position Draw and Mystery Cash Envelope. Entries after 40 are placed in position as they come in.
14. **Boat Inspection** - All live wells will be checked by a tournament official. All boats will be equipped with a live-well system able to sustain a limit of fish, and in working condition.
15. **Safety** - During all tournaments, contestants will wear their life jackets zipped and secured when combustion engine is in operation. During foul weather, you may take closest shelter. During any emergency, you must return to tournament site if possible.
16. **Sportsmanship** - All contestants are required to follow high standards of sportsmanship, courtesy and conservation. Drunkenness shall be cause for immediate disqualification. No illegal drugs shall be allowed in the boats during the tournament hours extending through the close of weigh-in.
17. **Off-Limits** - You may not fish closer than 50 yards to another competitor unless given permission. If permission is given to one, then all may fish the same water.
18. **You May Not Leave Your Boat During Tournament Hours Except During an Emergency.** - Partners must stay in sight of each other during tournament hours. If both partners must leave the boat for non-emergency reasons, you must notify the Tournament Director before doing so.
19. **All State rules and regulations must be followed.**
20. **Insurance** - Liability insurance is required of all contestants utilizing a boat in The Bernie Behnke Scholarship Tournament.
21. **All rules and regulations are subject to review by officials.**
22. **Tournament directors have the right to deny anyone's entry from any or all tournaments.**

1. **Liability Release.** In signing this agreement, I hereby release Lake Drive Marine (L.D.M.), its officers, agents, employees and sponsors from any and all damages, claims, demands, costs or expenses relating to injury of any persons or damage to any property which I may sustain or which I may cause by reason of participating in or in connection with this or any other L.D.M. Tournament.

2. **Covenant Not To Sue And Waiver Of Subrogation.** I further agree that I will never sue L.D.M. for damages on account of any injury or damage that I suffer or cause whether known now or which may develop in the future in connection with this or any other L.D.M. Tournament. I expressly agree to indemnify and hold L.D.M. harmless from any liability whatsoever, including court cost and attorney fees arising with respect to such actions. I understand that in waiving my rights to sue L.D.M., I also am waiving the rights of recovery from L.D.M. of my insurance carrier for any claims they may pay on my behalf. I further understand that by signing this agreement, I waive any rights my heirs or relatives have or may have to sue L.D.M. for liability.

3. **Verification of Liability Insurance.** I maintain liability insurance on the boat I will use in any L.D.M. Tournament for the 2013 Season.

4. **Construction.** If this agreement and the release, covenant, and waivers contained herein are found by any court to be overly broad in any manner, I ask the court to interpret it as broadly as possible.

5. **Reading and Understanding.** I signify by my signature that I have read and understand the agreements numbered 1, 2, 3 and 4 above.
